The successful bidder will take full charge of the day to day management and operationalization of the facility in provision of:

-Tea, coffee, soft drinks, snacks and a variety of food menus.

The facility is an extension of the Tourism, Culture and social services premises (The Resource center)

Located next to the County Government headquarters.

An outside patio dining area that can accommodate three Umbrella shades.

Ample and secure parking ground.

24hrs security provision.

Electricity (bills payable by the Cafeteria management)

A water storage tank

A washroom area.

Kitchen and store room
