The amendments in the Climate Fund Act 2020 are aimed at guiding and sustaining adaptation efforts within the County, and to strengthen locally led climate actions aimed at building community resilience while the aim of the Natural Resource Management Policy is provide a structured approach for the sustainable use, conservation, and management of natural resources by establishing guidelines, strategic planning and legal/regulatory structures.

he Orange Democratic Movement (ODM) on Monday sought to forestall a looming succession fallout by calling on party officials and members to rally behind its newly-installed party leader, Dr Oburu Oginga.

In the first meeting of the Central Management Committee since the death of party leader and former Prime Minister Raila Odinga, ODM warned its members against instigating internal political conflicts in pursuit of inheriting Mr Odinga's political

The move by the 20-year-old party comes in the wake of intense political jostling - within and outside ODM - to succeed the veteran politician, who since 1997 has remained a consequential political player in the country. Key political figures within and outside ODM - have launched behind-the-scenes machinations to inherit his support bases of Nyanza, Western and Coast, potentially threatening to split the outfit. Some of the interested players were already eyeing the control of the ODM party as a way of inheriting Mr Odinga's backyards, while others were seeking to plant themselves as the new regional king-

"Baba (Mr Odinga) built this movement on the foundation of values; democracy, equity, inclusion, and truth. ODM is not just a political party; it is a covenant. Let us resist the temptation to scatter in despair or to fight over his political inheritance as leaders often do when giants fall,"the party said in a statement read by its secretary-general Edwin Sifu-

"Raila's true inheritance is not a name or a position, but a mission. That mission is to continue the struggle for a Kenya that works for all its children, regardless of tribe, class, or creed. We commit here in unison, as we did during the funeral, that we will not be responsible for any breakup in the party, or any unnecessary political turbulence that runs counter to Jakom's

Since entering the broad-based government in 2024, the party has been caught up in vicious internal wrangles pitting pro-system politicians and an emerging group of radical youthful MPs opposed to the arrangement.

There are fears within the party that if the wrangles are not contained, ODM could follow in the footsteps of Ford-Kenya that was consumed by an internal firestorm following the death of its leader Jaramogi Oginga Odinga. Raila held ODM together for nearly two decades, masking factional rivalries beneath the unifying banner of his name. With that unifying figure gone, the party faces its greatest existential test since its founding in the aftermath of the 2025 referendum.

"Whatever ideological and political competitions within the movement must remain healthy, as Raila himself desired, while seeking to lay a strong foundation for the next election and beyond, so that ODM as a national party and the most consequential one in the last 20 years, does not fade from the scene," said,

Mr Sifuna. The Central Management Committee - the party's topmost organ – unanimously endorsed Dr Oburu as the new party leader. The 82-year-old Siaya Senator was appointed acting party leader on October 16, 2025, by the National Executive Council (NEC), a day after the death of Raila in India.

The party further announced its commitment to the broadbased government until 2027. This, even as the party indicated plans to pursue implementation of the 10-point agenda contained in the March 2025 Memorandum of Understanding between ODM and the ruling United Democratic Alliance (UDA) of President William Ruto.

Sharp differences

"As the top leadership of this party, we shall pursue all causes he dedicated his life to, do everything within our power to uphold the unity of the party and apply lessons learnt from our departed leader and comrade in the service of the nation and a people he loved and fought for."

"We reiterate the commitment of the Party to the broad-based government until 2027, a relationship guided by the 10-point agenda entered into for the sake of peace and stability of the

The deal with President Ruto has been at the heart of sharp differences within the party, which played out during the burial of Raila on October 19,2025.

Top party officials publicly clashed over Raila's position on whether ODM should back Dr Ruto's re-election bid in 2027.

While some of the officials said the party is under firm instructions from Raila to remain in the broad-based government, Mr Sifuna said it was the veteran politician's wish for the party to front a candidate in the next presidential election.
